- Re-establishment of the CHIETA beyond 2016 by the Department of Higher Education and Training Authority unless the legislative imperatives dictate otherwise.
- The QCTO pronouncement on current qualifications and any new legislative changes that may be implemented.
- Annual monitoring site visits and/or unscheduled site visits
- If relocation occurs, the accreditation/status lapses and your organization must notify and submit an application for re-approval to the CHIETA within 15 days prior to relocation
- Continuously meeting all the quality and compliance requirements of your approval status
- Learners must be registered with the CHIETA through submission of fully completed agreements and certified supporting documents before any training commences (i.e. off and on the job training)
- This approval will be revoked on the basis of poor performance and non-compliance to approval and training related requirements.
